



1ST VIRTUAL DANUBE WATER FORUM

The Importance of Water Sector Data in the Digital Age

Date/Time: 27-29 October 2020

Location: Online

Target Audience: national institutions (ministries, regulators); national water and municipal associations, local government and utilities from the Danube region; representatives from regional utility (IAWD) and municipality (NALAS) associations; representatives from regulatory agency platforms; representatives from the EU, GIZ, SDC and the World Bank; Young Water Professionals; academia; private companies; and others.

Concept: The availability of sound water sector data is the inevitable basis for achieving smart policies, strong utilities and sustainable services in the Danube region.

Given the highly unsecure situation due to the COVID-19 pandemic, the Danube Water Forum goes virtual. The Forum will address the importance of water sector data in the digital age in a three-day series of webinars.

Day one will start with welcoming remarks from the original hosts for the event from Banja Luka and will be followed by a high-level keynote speech to set the scene at the international level, before diving into the Danube region by showcasing how data availability helps evaluate the improvement of the water sector in the Danube region. This will be followed by a presentation on water sector data in the intersectoral context taking into account Integrated Water Resources Management and water security aspects.

Two sessions on the second day will address the interrelation between smart policy decisions and sound data availability; and the value of sound performance indicator data for financing water services will be discussed.

The third and final day will address the relevance of data collection as a basis for utility performance improvement and summarize the key findings of the Forum in a high-level panel discussion.
