Significance of the Conference

The water service sector i.e. water supply and sewerage and wastewater treatment service, has a direct and significant impact on the quality of life of the population in Bosnia and Herzegovina (BiH), as well as on economic development in general. However, the current state of the water service sector in BH is still characterised with the lack of clearly regulated roles and responsibilities, lack of individual, organizational and institutional capacities in the sector,

4th Regional Conference »Modernization of Water Services in BiH« aims to support the improvement of the water service sector through joint review and definition of next steps towards improving the legislative and legal framework, capacity development in the sector, exchange of knowledge, experience and best practices as well as strengthening co-operation and coordination of stakeholders at all levels. As in previous years, the Conference will bring together the most important actors from the water service sector from the local, cantonal, entity and state level of BiH as well as countries in South-East and Western Europe. As such, Aquasan Network in BiH and its partners continue contributing to the modernization of sustainable water service provision and promoting the importance of water services in BiH.

The Conference will be organized through joint and parallel sessions with an emphasis on participation of local government units (LGUs) and public utility companies (PUCs) through presentation of their experiences, examples of good practice and exchange of experiences as well as participation in panel and plenary discussions. This will ensure interactive communication and enable dialogue on challenges in the water services sector.


