

DAY 1: RELEVANCE



- European Commission: Joachim D'Eugenio European Green
 Deal European Data Strategy Digitization is coming for water sector
- ► Belgrade Waterworks: Maja Medenica Knowing your system: 4000 kms instead of 2500kms
- Sava River Basin: Dragan Zeljko: Integrating 15 different data systems; flood forecasting
- ► World Bank: Harsh Change your view or perspective by using data from different sources
- ► Global Water Partnership: Konstantin Ivanov Investing in Trust matters as much as in data infrastructure (e.g. drought watch)
- ► Austrian Environment Agency: Gabriele Vincze data sharing depends on data quality! And: Cost in Austria "upper six digit range actually"

DAY 2: DATA COUNTS



- ► Hungary Regulatory Authority: Gabor Kisvardai After eight years of data collection: complete revision why, how, what in collaboration, eliminated 40% of data collection burden
- ► Montenegro Regulatory Authority: Milica Petrovic data to determine fair tariffs objectivity, transparency, non-discrimination. Despite huge variation amongst operators: Benchmarking! "Good regulation needs good data"
- Netherlands, KWR: Peter van Thienen − 21% performance improvement through benchmarking. Also: Decision Support Tools: Reducing non-revenue water, better planning through modelling uncertainties
- ➤ Austria, University of Innsbruck: Heribert Insam— waste water monitoring for early warning/ prediction of COVID spread "waste water epidemiology"

DAY 2: TRANSPARENCY



- Municipality of Sombor: Antonio Ratkovic energy independence for the city's wastewater plant
- ► EBRD: Damir Cengic massive investments into green city infrastructure where cities commit to "green action plans", with targets on GHG reduction targets require data
